Qualified independent repair facilities (IRFs) and body shops are entitled to the rebates indicated on the rebate forms. Open to legal residents of the U.S. only. Rebate offers are limited to nine rebates per IRF/Body Shop for first quarter for each product offering (except otherwise noted). Rebate form must be complete and legible. Void once redeemed. No cash value. Rebate void if purchased, sold or bartered for cash or altered in any way. Not valid in conjunction with any other offer. Excludes fleet and auto auction accounts. Valid toward purchases made during valid specified promotional dates. Product must be purchased from a Chrysler, Jeep, Dodge or Ram dealership. Check will be payable to the business name. Request for rebate along with supporting documentation must be submitted or postmarked within 30 days of rebate offer expiration date.
